

From The Upper Room Emmaus Ministries Office ---- Guidance for the “reopening” of Emmaus Ministries Communities:

As dates of planned events approach, Emmaus Ministries communities have been reaching-out to the International Office for guidance. Amidst conversations around the reopening of economies, the lack of visibility in this COVID-19 pandemic environment is causing the Upper Room as a whole to continue to exercise, and to invite its constituencies to prudence.

At this stage, while the severity of the pandemic has been – arguably - drastically reduced as a result of radical social distancing measures, there remains a multitude of questions surrounding the nature, the transmission, the impact on the human-being, and an efficient response to the virus.

More than ever the future is filled of unknowns, and fear is a reality for many potential team members and participants. The impressive COVID-19 related death toll and the huge media focus – with, at times, spectacular footages – will remain engraved in many minds for some time. Here again, trauma and its consequences will be real for many potential team members and participants.

Therefore, as they deliberate, local Emmaus Ministries Communities are encouraged to be sensitive to these realities. Communities are furthermore encouraged to have participants’ and team members’ physical, mental, and spiritual wellbeing as their primary concern, and to ensure that (1) for the various aspects of the Emmaus Ministries event, team members are truly in a position to create an environment in which participants might experience the grace of God in new and life changing ways, and (2) participants are able to avail themselves to that transformative grace.

Where the decision to hold events is taken, Local Emmaus Ministries Communities are encouraged:

A- To follow Federal recommendations for gatherings




Plea for submissions:
